Wallace Trail Preservation Board Meeting

Monday, November 13, 2017, 7:00 p.m.

Wallace Township Building, 1250 Creek Road, Glenmoore, PA 19343

1. Attendees: Dorothy Kirk, Dan Wagner, Carol Zindel, Meredith Meyer, Mary Wasko, Sheila Fleming
2. Approval of prior minutes (October meeting cancelled)
3. Active Subdivisions--trail discussions with developers
4. Map review and Updates
5. Township Commission updates (Supervisors, Planning Commission, Parks & Rec., etc)
6. Current Trails and their projects:
 - a. Highspire Estates Trail—Need to replace one missing trail totem on outer trail. Trimming/clearing around Septic plant needed. *Ask Steve Senn (Township) for help*
 - b. Glen Dale Preserve - call Peter for closure dates
 - c. Brandywine Hill
 - d. Burgess Park, Hannum Woods loop
 - e. Springton Manor Elementary
 - f. Linking portions of the public trail system together
 1. Glendale to Springton Manor Farm trail.
 - i. Study/'Story' update w Brandywine Conservancy
 - ii. Maintenance on WTPA eased section
 2. Colonial Woods link to connect Brandywine Hill to Springton Manor Farm.
 - i. Trail eased by Township on Wheeler /Zindel properties. Ethan Matlack has cleared trail up to creek.
 - ii. To do: Work with Chester County (who owns a small parcel between Wheeler's and SMF) to get safe road crossing of Springton Road—first step before clearing remaining trail. Expected to be a year long process.
 3. Meet with Susan Giangulio to discuss maintenance on eased parcel on Indian Run Road
 - g. Wadsworth Subdivision - Barb D. will broach subject for us about crossing driveway closer to Highspire in lieu of current area proposed in plan. This would keep trail off Highspire Road
 - h. Struble Northern Trail extension:
 1. Former Valhalla / Greenfield (portions) are being preserved by NLT
 2. Colonial Woods Segment -Wheeler's donating RR bed parcel to Wallace with hopefully an easement to County for RR bed portion
 3. Village Trail Segment (detour of Village with former Greenfield property)
 4. Coordination with Brandy Conservancy (Mary W.)
 5. Greenway Concept Plan updates (Mary W.)
 6. Coordination with Rachel Griffiths , new Open Space Planner, Chester County Planning Commission, or with new Greenway rep
 7. PECO property/grant acquisition (on hold)

7. Ray Park: Perimeter loop request at 6-5-2015 BOS meeting, revisit once fields are planned; fields currently on multi-year farm lease.
8. M.A. Trail: Dorothy attended 5-19-2016 BOS mtg—received approval for bike and cross country ski icons to be added to trail posts, but not horses. BOS is reconsidering bike icon. Meanwhile, should add non-motorized icon, bike, cross country skiing
9. Get to know the Trails in Your area trail walks: One more before winter?
10. Eagle Scout project- Ethan Matlack has cleared Colonial Woods/Zindel trail, added wooden map signage. Ask Ethan for digital map (so we can modify, reproduce as needed).
11. VOSS sign order. Icons, replacements, plus 4 new totems - in progress. Get xtra totems from Ethan (ordered for Wheeler / Zindel trail). Add user group yielding sign x 2 for Wheeler trail.
12. Specific maintenance or new trail items for Grant (Sheila, Greenway). When do we need to submit any incurred expenses by? End of year?
13. New Business - need yield signs (which users yield to which other uses), as promised to Nancy Wheeler. Useful on other trails as well.
