Wallace Trail Preservation Board Meeting

Monday, February 12, 2018, 7:00 p.m.

2. Approval of prior minutes: None -- no meeting January
3. Active Subdivisions--trail discussions with developers: none
4. Map review and Updates: none
5. Township Commission updates (Supervisors, Planning Commission, Parks & Rec., etc)
6. Current Wallace Trails and their projects:
  - a. Glen Dale Preserve—NLT trail walk 2/13 at 12:30; ask Steve S. - chainsaw help.
  - b. Highspire Estates Trail—Replace missing trail totem on outer trail. Trimming/clearing around Septic plant needed. Ask Steve Senn (Township) for help. Adjacent Wadsworth property -- Barb D. will broach subject for us about crossing driveway closer to Highspire in lieu of current area proposed in plan to keep trail off Highspire Road.
  - c. WTPA eased segment (Gianguilio) near Indian Run Road schoolhouse - WTPA needs to meet with Susan G. to discuss maintenance on eased parcel - defer to Spring (too muddy now)
  - d. Colonial Woods / Zindel Trail
  - e. Brandywine Hill
  - f. Burgess Park, Hannum Woods
  - g. Municipal Authority - icons: Dorothy attended 5-19-2016 BOS mtg—received approval for bike and cross country ski icons to be added to trail posts, but not horses. BOS is reconsidering bike icon. Meanwhile, should add non-motorized.
  - h. Springton Manor Elementary
  - i. Alice Park - Trails have been planned on paper; when shall we implement them? Need to find map with approved trails - large plan. Want to talk trails to understand trails on plan.
  - j. Ray Park -- Perimeter loop request at 6-5-2015 BOS meeting, revisit once fields are planned; fields currently on multi-year farm lease.
  - k. Schneider Development trail
7. Linking portions of the public trail system together
  - a. Glendale to Springton Manor Farm.
    1. 'Story' update w Brandywine Conservancy
    2. Maintenance on WTPA eased section --meet w landowner to discuss
  - b. Colonial Woods to Springton Manor Farm
    1. Safe Road crossing to enter Springton Manor Farm. Work with Chester County (who owns a small parcel between Wheeler's and SMF) to get safe road crossing of Springton Road—first step before clearing remaining trail. Expected to be a year long process.
    2. Shall we apply for grants, do we need more than the bid from McMahon? Ask at 3/1 BOS meeting.
8. Struble Northern Trail extension:

- a. Colonial Woods Segment -Wheelers donating RR bed parcel to Wallace with hopefully an easement to County for RR bed portion
  - b. Village Trail Segment (detour of Village with former Greenfield property)
  - c. Coordination with Brandy Conservancy (Mary W.)
  - d. Greenway Concept Plan updates (Mary W.)
  - e. Coordination with Rachel Griffiths, new Open Space Planner, Chester County Planning Commission, or with new Greenway rep
  - f. PECO property/grant acquisition (on hold)
