 - a. Glen Dale Preserve
 - b. Highspire Estates Trail—Replace missing trail totem on outer trail. Trimming / clearing around Septic plant. Ask Steve Senn for help. Adjacent Wadsworth - Follow up w Barb D. (who would broach subject via Trust about crossing drive closer to road in lieu of current area to keep trail off Highspire Road).
 - c. Colonial Woods / Zindel Trail
 - d. Brandywine Hill - needs clearing. Mary W to send email to interested trail clearing helper's list.
 - e. Burgess Park, Hannum Woods
